Election Policy - additional information

- Nomination forms need to be signed and submitted via email to nominations@leedsunitedtrust.com
- This mailbox is monitored only by a member of the Election Management Group and only shared within the Election Management Group during the 8-week Election Period (Friday 20 October to Friday 15 December)
- The Election Management Group is comprised of an independent Chair, the Secretary of the Trust and two current members of the Trust
- None of the Election Management Group is eligible to stand or vote
- It is the responsibility of the candidate to check they have been nominated and seconded by people currently in full membership of the Trust
- Candidates can only submit their nomination form if they have been fully paid up members of the Trust since Monday 30 October. Any members who join after this date are not eligible to stand.
- Should the EMG receive more nomination forms than there are spaces available and it becomes necessary to vote on which candidates join the Board, members that have joined after Monday 6 November will not be eligible to vote
- Nominations will not be shared publicly until the 8-week period has ended and it has been determined if there are more candidates than board places
- In the event that there are more candidates than places, all candidate's personal statements and photos will be published on the Trust website ahead of a vote amongst all members
- Members will be given a week-long period (Friday 15 December to Friday 22 December) to submit their online vote for the candidates of their choice
- The new Board members will be announced as soon as possible following the close of the online vote on Friday 22 December
